I acknowledge that I have sole responsibility for the safety of my crew and yacht.

The Venture Yacht Club and any other event sponsors are in no way to be held responsible for accidents, damage or injury to property or to yachts, crew or guests arising from any cause during or related to any event for the above mentioned period.

Weather and sea conditions must be evaluated by each Skipper and his crew and each participant is responsible for determining whether it is safe for him or her to participate. The responsibility of wearing a life jacket rests upon the Skipper and his crew. If assistance is provided by Committee vessels and personnel, it is at the risk of the participants.

I hereby agree to all Conditions for Venture Yacht Club events and shall inform each member of my crew of these conditions. I hereby warrant that my yacht will be outfitted, equipped and handled in accordance with these Conditions; that she will have all required equipment aboard; that she is seaworthy in hull, rig and gear; that she will be completely manned.

In consideration of your accepting participation in Venture Yacht Club events, I do for myself, my executors, my administrators, and assigns waive and release any and all claims that I have against the Venture Yacht Club and any other event sponsor, their officers, directors, members, committeemen, volunteers, employees and agents, or any one or more of them or their executors, administrators, heirs, next of kin, successors or assigns, including any or all claims for damage caused by the negligence of any of them arising out of my participation or that of my yacht in Venture Yacht Club events and related its related activities, including pre-start and post-finish operations and shore activities together with any costs and expenses including attorney's fees that may be incurred as a result of any such claim whether valid or not. I do hereby agree to indemnify and hold harmless each of them against any such claim that any officer, member of my crew or one of my guests (or the executors, administrators, heirs, next of kin, and assigns of any of them) may have or assert together with any costs and expenses including attorney's fees with respect thereto.
